As at 31 December 2005, Dragon Capital Markets Limited also beneficially held 404,566 redeemable shares of the Company for proprietary trading purposes.
- (ii) Richard McKegey is a director of NIG Asian Investments Ltd., a wholly-owned investment vehicle of the National Bank of Kuwait, which is a beneficial shareholder of the Company, holding 1,500,000 redeemable shares as at 31 December 2005.
- (iii) As at 31 December 2005, Peter Williams C.M.G. beneficially owned 93,708 redeemable shares of the Company.
- (iv) Wong Sin Foong is a Country Manager for the International Finance Corporation (the IFC), which is a shareholder of the Company, holding 6,786,880 redeemable shares as at 31 December 2005.
